 - Andrea: Want to expand on the notion that some students are on PAPP but are not paying equal tuition fee payment throughout the year (specifically International Students). They receive a tuition award to offset the international fees (\$5000). In September 1/3 of this is credited to their account, and tuition fee payments are adjusted to account for this. Distribution to Councillors to come with more information (via Eric).
 - Victoria: Is there any rationale as to why the \$5000 is not credited up front?
 - Andrea: The message is that next year they will be doing this.
 - Julian: Are these tuition awards treated differently from QGA?
 - Andrea: QGA goes directly to students' bank accounts, rather than Queen's account. So this is "real" money rather than an account credit.

 - Eric: Busy month for the Bylaws and Policies. There will be quite a lot coming thru in January for the AGM deadline. I am also working with the AMS to draft bylaws for the SLC.

4. Senator, Board of Trustees, Commissioner, Committee & Other Reports

- a. Graduate Student Senator – Daniel Moore (report attached)

- Daniel: Busy month working on the Academic Plan. Graduate Studies needs to be taken more seriously in the future renditions of the plan. Currently every year a small task force will be created to review the plan. They will be looking at it with specific concerns in mind such as virtualization etc. Re: QFA enrolment suspension - Dean of Faculty of Arts and Science has cancelled enrolment for next year. The reason being, the faculty were worried about being able to run the program with the retirement of one of their professors. They were unsure as to whether they would be given funds to hire an additional professor. This was brought up at Senate but the motion was tabled. This also came up at the Faculty Board where a petition to reverse the decision was passed. Hopefully this will make a case for allowing further enrolment, we will know more in January. Also: SCAD is considering adding a new “dropped” status on transcripts, allowing you to drop a course anytime, but you will get a permanent notation on your transcript, and no refund (after set dates).
 - Torn (for Nikoo): Concerns re: employers.
- b. Graduate Student Trustee – Benjamin Grant (no report)
- The Board of Trustees met ~ 2 weeks ago with little actionable items passed. Residence fees were increased by an average of 4.5%. A grocery store and pharmacy lease were approved for the Queen’s Center. There are unlikely to be any increases in government spending for post-secondary education.
 - Andrea: Were there questions in the room thinking that specialization (HECO) would be a good thing?
 - Ben: Mixed responses.
 - Daniel: We previously spoke with Principal Woolf about “specialization” and he was hesitant at the time. Did he speak to this?
 - Ben: No, he didn’t make any comments that I recall.

5. Question Period/Departmental Issues

- Anne-Marie: I was wondering if anyone from the Strategic Planning Committee can give us a report about a survey from last year...
- Ben: I am Chair and will have an answer for next meeting.
- Melissa: (to Daniel) so you can currently drop for exceptional circumstances at any point, so why discuss it?
- Daniel: To standardize the process.
- Eric: I do believe it is all part of the standardization process.
- Andrea: What changes now is that the appeal possibility has gone. You would not be able to appeal having a DR show up.
- Cody: I also worry about not having a process to drop a course because it seems like this becomes more of a lack of support for students – you won't see all the support venues available that might be able to help you through the course if you just walk away from it.
- Anne-Marie: Differentiation/Specialization advice (as mentioned earlier) comes from the government, assessing the quality of education in Ontario. The irony is that these people are legal and financial experts, not pedagogical experts. Differentiation may be a means to help with the financial situation. It could mean having only research-focused institutions, or speciality centers. The Principal does not think it would be easy to separate teaching from research, but he is on board with the idea of separating the fields to become better at fewer things at any one institution. The concern we have here relates to accessibility, especially financial accessibility having only one institution for example, at the other side of the country. This committee also produces research reports, some of which are questionable.

- Andrea: Comment about Daniel’s report. I note that you thank Mark Jones in your report and I wanted to echo this. Maybe we can formally recognize the hard work that he is doing in a letter of thanks? He is a great advocate.

WHEREAS Queen’s recently and unilaterally suspended new admissions and upper-year transfers to the Bachelor of Fine Arts (BFA) program for the 2012-13 academic year based on an assessment of the faculty resources available to support the program; and

WHEREAS this decision sets a precedent for future closures, freezes, and amalgamations of undergraduate and graduate programs at Queen’s; and

WHEREAS, under the “Purpose and Functions of Senate,” the central function of Queen’s Senate is to “determine all matters of an academic character that affect the University as a whole”; and

WHEREAS Senate is also authorized to “approve university-level policies relating to the academic mission and academic services including but not limited to policies related to admissions”; and

WHEREAS a petition is currently being circulated by campus community members asking that “the BFA admissions-freeze and all such contemplated freezes, closures, and amalgamations be henceforth submitted to the proper authority of Queen’s Senate for approval,” that “all such policy decisions (...) be based not only on financial or ‘resources’ criteria but on long-range

academic considerations,” and that the broader Queen’s community be consulted in the process; and

WHEREAS a motion was passed at a recent annual general meeting of the Canadian Federation of Students tasking the CFS Executive to write a letter to Queen’s Administration asking that the aforementioned decision-making process be respected; therefore

BIRT Council endorse a letter to Queen’s Senate requesting that admission freezes, closures, and amalgamations henceforth be considered by Senate and be given academic as well as financial consideration.

BIFRT individual Councilors be encouraged to sign the petition to this same effect <http://www.ipetitions.com/petition/noclosurewithoutprocess/>.

Anne-Marie: As Daniel already mentioned the University has been looking at cost cutting measures for the Bachelor of Fine arts to ensure the sustainability of the program. Last year enrollment increased by 50% unexpectedly. Based on staffing shortages and the cost to the University to maintain the program the Faculty of Arts and Science unilaterally announced suspension of admission. A consultative process would have been more appropriate. This decision was not made by the Board of Trustees. This motion is to highlight that the process by which the program was cut undermines the authority of Senate. It also opposes a precedent that this decision by the Faculty of Arts and Science may set. It is also opposed to setting a precedent that financial considerations outweigh all others.

Melissa: I don’t know anything about this college of Arts and Design. What is the point of including this?

Anne-Marie: It has been reported consistently in the media and compared to Queen’s.

Melissa: Given we are a broader institution I’m not sure that they fit well in the letter.

Daniel: I noticed that at the end of the motion it asks that admission freezes etc. henceforth be considered by Senate. I think we should just ask that this is directed towards Senate rather than telling them how these decisions should be made. I would add “Henceforth be brought to Senate before implementation”. The Dean should have some say in this process, but it is his responsibility to bring it to Senate.

Cody: I want to echo that this is not just about Fine Arts programs. It is important to protest this decision making process, on record so we are not setting a precedent.

Jillian: Although it is not in the motion I would strongly urge you all to look at the petition and consider signing it, and to convey this to your department.

Ben: The Dean of Arts and Science is facing extreme constraints – all Departments have been told to balance their budgets by next year. Dean MacLean would not have done this unless he felt that he had no choice.

WHEREAS Library and Archives Canada (LAC) is a crucial national institution which acquires and preserves documents relevant to Canada's cultural and historical heritage; and

WHEREAS LAC has a mandate to collect, preserve and make public a unified national collection; and

WHEREAS the services and resources of LAC are used by a large and diverse group including the general public, librarians, historians, professional writers, students, genealogists, Aboriginal communities, as well as researchers and scholars from virtually every discipline; and

WHEREAS current management at LAC has implemented changes that are having far-reaching implications including reduced public access, decentralization of the national collection, elimination of specialist positions, and reduced acquisitions; and

WHEREAS the Canadian Association of University Teachers has launched a campaign to 'Save Library and Archives Canada' (www.savelibraryarchives.ca) which calls for clarification of the LAC mandate, adequate funding, restoration of acquisitions and public services, and the cessation of defragmentation of the national collection;

BIRT Council endorse the campaign to Save Library and Archives Canada.

BIFRT Council send a letter to Heritage Minister Mr. James Moore and to the Librarian & Archivist of Canada Dr. Daniel Caron through the campaign website (transcript of the online letter in Appendix 1).

Anne-Marie: Some context – in 2009 the Federal Government appointed the Head of the LAC who was the first who was an economist. His first strategy to save money has been to re-structure things through a "modernization" process involving digitization. It also involves a moratorium on all new acquisitions, which was lifted in 2010 but the acquisition rate is still significantly lower than before the moratorium. A lot of cultural heritage which came up for acquisition has been lost. (Contrary to their mission statement of collecting a record of everything relating to our heritage). This was able to be passed because the mandate was restructured by this new appointee. For the academic community, our collection has largely been decentralized, and public access has been reduced as specialist positions have been eliminated through the digitization process. In addition, researchers have to exert greater effort not only to find the information, but also to pay more to travel to other locations, and in some cases perhaps pay private collectors for access. Our letter addresses many of these concerns.

Irene: Can we add how many members the SGPS represents?

Anne-Marie: Yes

- the dental bursary program should be extended to include services that exceed the maximum coverage limit of the SGPS Dental Plan (currently at \$750)
- the dental bursary program should explicitly exclude emergency dental procedures that are covered at 100% by the Health and Dental Plan

BIRT SGPS Policy P.1.4 be repealed in its entirety and be replaced as seen Appendix 2. (Changes Tracked in Appendix 3)

Andrea: This is a policy change that last year's Finance and Services Committee recommended. If we were to extend the dental bursary the premiums would significantly increase. Having extra funds available for extremely expensive procedures may be a better solution. However, last year the committee noticed that individuals were approaching with requests for funds that exceeded the Green Shield coverage amount. This policy change simplifies this process.

Matthew: Does this tap into PSAC funds?

Andrea: That is all still up in the air – how best to have these funds work for TA/TFs.

Julian: Will this impact the bursary usage rate?

Andrea: I doubt it. A few more may come through but people are not likely to abuse their ability to go to the dentist.
